Soil Movement – The house was tunneled under in order to replace the plumbing. There has been soil settlement since plumbing was replaced at beginning of 2022. Important to keep foundation watered.

Improper Drainage – During heavy rain water has pooled near back door. A french drain was recently installed to remedy this issue.

Previous Fires – There was a fire reported to insurance approximately three years ago. The cause was unrelated to the structure of the home... paperwork caught on fire in office and caused smoke damage. Insurance claim was made which covered the cost to properly clean the home but there was no structural damage to the home.

*A single blockable main drain may cause a suction entrapment hazard for an individual.


